Bring the United States back into the Paris climate agreement.

No New Leases in the Gulf of Mexico, Cook's Inlet, or anywhere.

Place the state of Florida in a permanent moratorium against offshore drilling and exploration.

Say no to opening the Arctic National Wildlife Refuge and other public lands to oil drilling or exploration.

Restore the Clean Water Act and the Endangered Species Act.

Invest in and implement a economic recovery plan that has a strong emphasis on a renewable energy and job creation/market that focuses on lifting up communities of color.

Transition off Fossil Fuels. Develop a comprehensive plan that addresses the transition of FF workers, creation of a tax base for areas that will lose those taxes, include remediation jobs that address decommissioning and cleanup activities. Implement the Climate President Plan.

Create a White House Climate Office.

End Factory Farming.

Stop horse, bear, and other wildlife executions as means of population control.

Implement programs and incentives that encourage farmers to move to organic farming.

End all animal testing.

Implement a national mask mandate until COVID 19 is under control.

Install EV charging stations (powered by solar/wind) along every major highway in the U.S.

Transition Federal and state "environmental protection" agencies from allowing industries/businesses/individuals to pollute at will. Create agencies that don't just regulate pollution, but provides meaningful enforcement of regulations. Ensure that they provide real preservation, conservation, restoration, and protection of natural resources, all species, and public health. 
The Rights of Nature

Federal solar tax credit

The federal solar tax credit, also known as the investment tax credit (ITC), is one of the best financial incentives for solar in the United States. However, this solar incentive will be phased out starting in 2020, with the exception of commercial solar installations.

2020: Owners of new residential and commercial solar can deduct 26 percent of the cost of the system from their taxes. 2021: Owners of new residential and commercial solar can deduct 22 percent of the cost of the system from their taxes. 2022 onwards: Owners of new commercial solar energy systems can deduct 10 percent of the cost of the system from their taxes. There is no federal credit for residential solar energy systems. Source: energysage.com



There is a current collective push to have the credit re-established to the 2019 criteria. There have been at least two extension since it's inception as part of the Energy Policy Act of 2005.
